Candidates for Membership

Under Sections 5 and 7 of Articles of Association of ALFA:

6. (b) The Council may, in its sole discretion, appoint persons as student members. Such members may attend all meetings but shall not be entitled to vote thereat nor to stand for nor be elected as an office bearer or Councillor.
7. (a) Every proposal for membership shall be in writing and sent or delivered to the Executive Director.
7. (b) A candidate for membership shall give his full name, address and occupation and if a body corporate the full name, address and occupation of its nominated representative and any further information which the Council may from time to time by any by-law prescribe or in any particular case require.
7. (c) A candidate for membership may be elected or appointed respectively by a majority of the Council who shall if so requested by the candidate or any member of the Council proceed by secret ballot. In no case shall the Council be required to give any reason for the rejection of a candidate.
7. (d) On the election or appointment of a new member the Executive Director shall notify the fact of election or appointment to that member in writing by prepaid letter sent to the address given as above required and request payment of the annual subscription. In the event that the new member is elected or appointed on a date other than 1st July then the aforesaid annual subscription and levy for the first year shall be the amount of such annual subscription and levy pro-rated on a daily basis for the number of days between the date on which the new member is elected or appointed and the following 30th June.
7. (e) Despite his election or appointment as a member, no newly elected or appointed member shall be entitled to enjoy any of the rights, privileges or benefits of membership of the Association until all such payments have been made; when made he shall become bound by the Memorandum and Articles of Association of the Association. If such payments are not made within one (1) calendar month from the date of the posting of the aforesaid notification by the Executive Director, the election or appointment as a member shall be void.
